## **Remove Conditions on Standards 4, 5, and 6.**

**Place Condition on Overview 09:** UPR Utuado needs to report how it informs the public regarding their performance including student learning achievement. They describe communication activities but do not specifically provide information on how they inform the public on their performance, including student learning achievement as well as what is reported.

Describe how you routinely provide the following results to the public. **1. Student Learning Outcome Assessment Results:** Such as what you report in standard #4, ETS, MFT, accounting assessment, management assessment, critical thinking, communication, etc. **2. Program Results:** Such as what you report in standard #6, graduation rates, retention rates, job placement, etc. If you provide a link to aggregate business student results please ensure the link goes directly to the results such as this link:

Please ensure that all appropriate information is on the web site and include a link that works.

The Condition must be removed by 9/15/2018 and progress toward the removal of the condition must be reported in your next quality assurance report. Your next quality assurance report will be due 9/15/2016 and your reaffirmation is scheduled for 2021.
